Proposal: Change of use from A1 to mixed use A1/A3

including air conditioning units, new signage &

associated works

Location: Shoe Zone, 44-45, High Street, Tenby,

Pembrokeshire, SA70 7AA

I refer to the above-mentioned planning application which you have previously been consulted on.

I write to advise that the information/comments below have been received, following ongoing communication with the agent and Public Protection.

I would be grateful to receive any comments you may have within the next 14 days.

1. In relation to the current Greggs: the use was considered to fall within Class A1 use as defined by the Use Classes Order 1987 (as amended) due to the amount of table and chair seating proposed (3 in total at the time). It is recognised through planning guidance available that in Class A1 use for example, sandwich bars are included within this use class but shops for the sale of hot food fall within the A3 use class. However, in considering where such a use should fall, advice is also given that it is the primary purpose that should be considered and that a sandwich bar does not cease to fall within Class A1 merely because it also sells hot drinks or if a few customers eat on the premises.

2. The waste will be placed in sealed containers/wheelie bins and put out an hour before collection is due on the day of collection and placed at the top of the alleyway – Public Protection are happy with the waste point.

3. Public Protection would be happy if there was a pre-commencement condition that said Greggs would be required to do a BS4142:2014 assessment (noise levels) prior to installing equipment and opening.
