126b. TTC welcomed Julie Jones and co-volunteer, Tegryn Jones, who are part of the working committee **Eisteddfod Genedlaethol y Garreg Las 2026** raising awareness and money for Tenby and area. Pressures were outlined as were the benefits to county and town. Councillors were then given a presentation. The lead up and legacy. Deep rooted event in Welsh culture with an upcoming 850-year anniversary.

Fund raising events have already take place with more planned to include a Christmas market in Sergeants Lane.

TTC will look at ways that Tenby schools and Tenby residents can be involved and the benefits to the local community. Possibly support by providing transport to the venue for those taking part and supporters.

This may be unfamiliar terrain to those who are newcomers to Wales and to a certain generation of locals. On-line workshops may be beneficial 'what is Eisteddfod'.

TCC commit to ongoing dialogue, 2026 flowers in colour scheme, event linking where possible, look at enhancement to Tenby St David's week events, grant regime, look to favour items linked to Eisteddfod, look to support transport to event, accessible bus, to support school involvement and to keep ideas flowing. Cllr Blackhall proposed £5,000 as a starter and to keep item as a standing item on Agenda, seconded by Cllr Skyrme-Blackhall.
