Councillors agreed that the building is important to Tenby's history, its character should be retained, suggesting more sympathy to original design. Also considered heritage element. It was felt there should be no need to significantly alter frontage.

Councillors asked if there was any section 106 applied to development. Cllr Lewis proposed, Cllr Phillips seconded.

- b. Conservation Area Tree Works Application - Proposed Works: Line of previously coppiced Sycamore needs to be re-coppiced: St Teilos Rc Primary School, Greenhill Road, Tenby, Pembrokeshire, SA70 7LJ – note for information**

Least useful broadleaf tree. Oaks would be a different matter. Primarily a human amenity.

The Mayor proposed no TPO and to inform applicants that works go ahead. Cllr Spence seconded

- c. NP/25/0652/FUL - Change of use from shop unit to office use. New first floor office space, replacement windows & shopfront. Repairs to fabric: 2-4 Ventnor House, Griggles, Warren Street, Tenby, SA70 7JS**

Councillors agreed that windows should be sympathetic with original design but that it was good to see area being tidied up.
